## **GENERAL TERMS OF AGREEMENT**

To qualify for wholesale purchases, you must be a valid retail business and by agreeing to our terms and conditions you certify that you are such. You are only authorized to sell through the retail store that you have listed. Secondary stores, as well as website and online sales must receive prior written approval.

## **ORDER REQUIREMENTS**

We ask that you spend a minimum of **\$1000** on each order of wearables placed with a minimum of **\$250** on each order of home goods. A reorder minimum of **\$500** for wearables and **\$100** for home goods is also required.

Due to limited stock, we ask that you do not order more than **10** amount of the same product in order to respect production and shipping deadlines.

Due to high demands for **December**, all orders for this specific period must be placed before the **1st of November**. We can't guarantee our usual delivery time if an order is submitted after this deadline.

## **PAYMENT INFORMATION**

We accept payments via **Credit Card, PayPal, and Venmo**.

Net 30 terms available once we have established a relationship and of accounts.

50% of the orders must be pre-paid and 50% must be paid before shipping of the goods. You will be emailed the invoice and goods will be held for **7** days pending payment. Please note that we only hold limited stock so all orders will be held for a maximum of **14** days being reallocated to another stockist. No orders will be processed until the first payment is received. Orders may be canceled within **5** business days of the order placement. Cancellations after 5 days will incur a fee of **20%** of the entire order.

We reserve the right to alter our prices at any time unless prior invoiced.

## **SHIPPING & HANDLING**

The retailer incurs the shipping costs but **RAANU** will insure packages with the carrier. Delivery is typically within **3 to 5** days of production. We use **Sendle**, a carbon neutral carrier. If your shipment is damaged in transit you agree to contact **RAANU** within **3** days of delivery.

Any problems must be reported in writing or by email with attached photo and retailer cannot return goods until he has received a written authorization. Goods sent back without one will not be credited to your account.

## **PRICING POLICY**

Goods must not be marked-up or marked-down without a written consent of **RAANU**. Goods should be sold to consumers between **100%** and **110%** of the MSRP. Goods can be sold at discounted price. The discounted items can't be sold at less than **80%** of the MSRP.
